



**Information and Rules for Entry  
2019 LEXUS Car Raffle**

1. The Torrance Education Foundation 2019 Toyota Car Raffle is a benefit for Torrance Education Foundation (“TEF”). Proceeds benefit TEF programs for students enrolled in Torrance Unified School District.

- Vehicle:** 2019 LEXUS NX300h generously donated by Toyota Motor North America
- Raffle Ticket Purchase Price:** 1 Ticket = \$30.00  
There is no limit to the number of tickets a single person may purchase.
- Eligibility:** You must be 18 years of age to participate. Should the winning ticket holder prove to be a minor, the selection of that winner will be considered null and void, and a new winner will be drawn from the same pool of raffle tickets minus the first ticket drawn that proved to be ineligible. The replacement drawing will be held in the presence of no fewer than three TEF board members.  
  
Employees of TEF and their immediate family members, including significant others and other individuals sharing a TEF employee’s residence, are ineligible to win.
- How to participate:** Ticket purchase forms are available for download at [www.TEF4kids.org](http://www.TEF4kids.org). Purchasers should complete the form by providing all requested information, include payment in the appropriate by check made payable to Torrance Education Foundation, or TEF, or provide a credit card number and authorization information, and mail to Torrance Education Foundation, P.O. Box 1397, Torrance, CA 90505.  
  
FEDERAL LAW PROHIBITS SALE OF RAFFLE TICKETS VIA INTERNET. Tickets cannot be purchased at [www.TEF4kids.org](http://www.TEF4kids.org). However, complete instructions and information are available.
- Quantity/odds of winning:** No more than 5,000 tickets will be sold.
- Direct School Support Initiative:** TEF offers purchasers the opportunity to designate an individual TUSD school or approved school-related group to be the beneficiary of their ticket purchase. Designees will receive \$20 of every \$30 ticket sold.  
  
Grants will be paid by TEF to designees no later than May 31, 2019. Only TUSD schools and approved TUSD school-related groups qualify. TEF reserves the right to determine if a requested designee qualifies for direct support.

- Deadlines:** Tickets will be sold until 7:00 p.m. on May 4, 2019.  
  
Ticket purchases with named designees must be received by TEF, or postmarked if sent by mail, no later than Friday, April 19, 2019. Any ticket purchases with named designees received by TEF after this date will forfeit the designation, but the purchase will still benefit TEF philanthropic programs for TUSD.
- Winner:** The winning ticket will be drawn at the conclusion of the annual TEF Silver Anniversary Gala, which will take place on Saturday, May 4<sup>th</sup>, 2019 at the DoubleTree Hotel in Torrance.  
  
The winner will be announced by the close of business on Monday, May 6<sup>th</sup>, 2019 on [www.TEF4kids.org](http://www.TEF4kids.org).
- Disputes:** Decisions of Torrance Education Foundation will be final.
- Disclaimers:** Torrance Education Foundation assumes no responsibility for ticket purchases that fail to be received due to misdirected mail, or by failure of volunteer solicitors to meet established, published deadlines.

2. The chances of winning are dependent upon how many tickets are sold to eligible purchasers and qualify for inclusion in the drawing. No more than 5,000 tickets will be sold;

3. Participants must have reached the age of 18 by May 4<sup>th</sup>, 2019, be an individual legally residing in the continental U.S., and be a licensed driver;
4. All prizes shall be awarded. The one prize to be awarded is a 2019 LEXUS NX300h vehicle.
5. The winner of the prize vehicle (“Donated Vehicle”) may not be an employee of Toyota Motor North America (“TMNA”), that entity’s advertising agencies, or any of the aforementioned entities’ affiliates or subsidiaries, nor an individual domiciled with any such employee;
6. The winner of the Donated Vehicle may not be an employee of TEF, nor a member of a TEF employee’s immediate family including a cohabitating significant other.
7. Prizes are non-transferable (e.g., winner must take title to Donated Vehicle), and no substitutions on any prizes (except that TEF and/or TMNA reserve the right to substitute prizes of equal or greater value);
8. TMNA shall not have any responsibility or liability whatsoever for any property loss, damage, personal injury, or death, in connection with the prizes provided pursuant to the Opportunity Drawing; provided, however, that TMNA shall be solely responsible for any express written limited warranties specifically set forth in the applicable Owner’s Guide for the Donated Vehicle;
9. The depiction of the Donated Vehicle in any advertising or promotional materials may not reflect the actual vehicle delivered to the winner (and TEF shall use its best efforts to place said disclaimer on all applicable vehicle displays and other advertising or promotional materials depicting the Donated Vehicle to be awarded);
10. The Opportunity Drawing shall be staged in compliance with all applicable federal, state and local laws;
11. The Opportunity Drawing shall be void where prohibited or restricted by law;
12. The winner shall be required to execute and notarize an affidavit of eligibility and liability/publicity release and return such affidavit to TEF within fourteen (14) days or an alternative winner shall be selected.
13. If the winner lives within a reasonable distance of Torrance, California, the winner shall execute the necessary paperwork and take delivery of the Donated Vehicle at TEF’s partner dealership, located in Torrance. If the winner does not reside within a reasonable distance of Torrance, California, special arrangements for delivery and transfer of ownership will be negotiated between the winner and TEF.
14. The winner shall be responsible for all taxes, license, title and registration fees and any other costs, including without limitation any travel or transportation costs, associated with winning the Donated Vehicle. Such fees are required to be paid prior to winner taking possession of the Donated Vehicle.
15. TMNA shall not be responsible for delays in delivery of the Donated Vehicle, and delivery is subject to availability. All reasonable efforts shall be made to deliver the Donated Vehicle within one hundred and eighty (180) days after receipt of the aforementioned items/information. In the event of delay, the winner must personally retrieve the Donated Vehicle within 14 days of written notification of delivery and must present adequate personal identification and evidence of legally required insurance (or an alternative winner shall be selected and the original winner’s rights to the Donated Vehicle shall be automatically forfeited); and

Acceptance of a prize constitutes permission for TEF and TNMA and/or their designees to use the winner’s name, address, photograph, testimonial or other likeness and/or prize information or personal exposition (and/or any edited portion thereof) for promotional, advertising and /or publicity purposes in any media, now or hereafter known throughout the world in perpetuity, without compensation or notice to, or further consent of, the winner to the greatest extent permitted by law.
